- **Letters of Recommendation:** Recommendation from academic or professional referees who can attest to your abilities, character, and potential for success in the program is required.
- **Passport Data Page:** Applicants are required to provide the data page of their passport. If the passport is not available, it is essential to initiate the process immediately to obtain one.
- **Passport Size Photo:** A passport-sized photo taken on a white background is necessary. We offer the convenience of taking this photo on the spot, free of charge.
- **Birth Certificate:** Applicants must provide a copy of their birth certificate.
