

SERVICE DETAILS AND PROCEDURES FOR VOCATIONAL TRAINING IN GERMANY (UPDATED)

Why Pursue a Vocational Diploma Course in Germany?

Requirements: Documents to be Provided by the Applicant

- **Minimum GCE Ordinary Level Certificate or BEPC:** Applicants must possess a minimum of GCE Ordinary Level certificate or BEPC. If you do not meet this requirement, please refrain from contacting us.
- **German Language Proficiency (Goethe Institute Certificate B1):** All applicants are required to demonstrate proficiency in the German language with Goethe Institute Certificate B1 and B2 for nursing personnel. We also welcome applications from individuals willing to study the German language for a minimum of six months.
- **Passport Data Page:** Please provide a copy of the passport data page. If it is not available, we recommend initiating the passport application process immediately.
- **Passport Size Photo:** Please provide a passport size photo taken on a white background. If needed, we can assist in taking the photo on the spot free of charge.
- **Birth Certificate:** Please provide a copy of your birth certificate.

Age Requirement: Applicants must be between 18 and 29 years old

- **Offer and Interview:** You will receive an offer within 48 hours and be scheduled for an interview with the employer within a one to two-month period.
- **Employment Training Contract:** Upon successful selection, you will be required to sign an employment training contract with the employer.
- **Visa Application:** We do not require blocked accounts or bank statements for the visa application.
