Requirements

Documents to be provided by the Applicant

- Minimum GCE Ordinary Levels or Equivalence
- Language Proficiency: French or English. No Certificate needed
- Passport Data Page
- Passport Size Photo: It should be taken on a white background
- Copy of Birth Certificate
- ID Card
- A CV

Process Cost

- The total cost is **5 Million Francs CFA** with flight ticket inclusive.
- Pay a non-refundable service fee deposit of **500.000 Francs CFA** and obtain a job contract through an interview with the employer.
- After obtaining a job contract, pay a refundable **2 Million Francs CFA** and obtain your work permit/Visa.
- After obtaining your work permit/Visa, pay a balance of **2.5 Million Francs CFA** and obtain your flight ticket.

Processing waiting time: 3 - 6 months

Benefits

- **Accommodation:** A minimum of three months accommodation is provided depending on the employer
- **Medical Insurance:** The employer provides medical insurance coverage for the duration of your employment, ensuring access to healthcare services and peace of mind.
- **Contract:** A two to three years employment contract with the option to renew, providing stability and clarity regarding your employment terms and conditions.
- **Airport Pickup:** A warm welcome upon your arrival, including airport pickup and transportation to your accommodation.

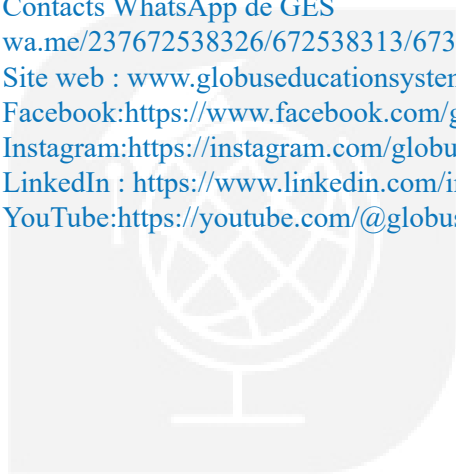
