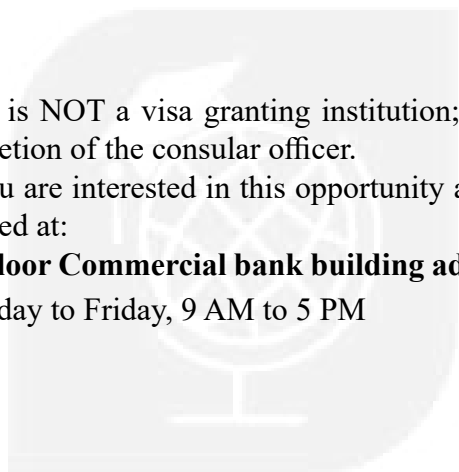

Engaging in any of our services means you have read and understood the terms and conditions of the refund policy provided by Globus Education Systems (GES).

Refund Policy for Direct Forester job in Norway

We appreciate your trust in Globus Education Systems (GES) for your direct job opportunities. Kindly review our refund policy for Direct jobs below:

- 1. Cancellation Refund:** The following outlines our refund policy for clients who decide to cancel their application services after making an initial deposit:
 - Refund within One Week: If a written request for cancellation is received within one week of the initial deposit, a full refund will be issued, minus a 10% administrative fee.
 - Refund within Two Weeks: If a written request for cancellation is received between one and two weeks after the initial deposit, a refund will be issued, minus a 20% administrative fee.

Please note: Cancellation refund requests are only valid within the first two weeks after initial deposit is made.

- 2. Visa Rejection:** If your visa application is rejected you must provide a visa rejection letter within 1 week after rejection to GES. Failure to provide a visa rejection letter will prevent any refund process.
- 3. Refund Responsibility:** Depending on who paid the first and second deposits, the same party will be responsible for following up with GES to initiate the refund process.
- 4. Non-Refundable Service Fee:** Please note that a non-refundable service fee of 500,000 XAF applies, and visa and work permit fees are also non-refundable once the application process starts due to government processing costs.
- 5. Waiting time:** Refunds are done within 30 days after the request is made with the visa rejection letter.
